<b>Eligibility requirements for participants</b>	<p>School teachers from Queensland primary schools and parents/guardians of students who are registered for home education in Queensland can enter on behalf of their class/school.</p> <p>Only one entry can be submitted per class. Multiple entries can be submitted for each school.</p>
<b>Entry Method</b>	<p>To enter, the class must submit an image of an original artwork which may have been completed by the class or an individual in the class.</p> <p>The image must be submitted in a .PDF or .JPEG file via email to: <a href="mailto:education@crrda.org.au">education@crrda.org.au</a>. The file name must include the school name and class name or (in the case of a home education arrangement), the student surname and initial.</p> <p>The entry email must include:</p> <ul style="list-style-type: none"> <li>• The school name / home education registration details</li> <li>• The address of the school / home education premises in Queensland</li> <li>• Class name/year level</li> <li>• Authorised class contact name</li> <li>• Authorised class contact details (email and phone number)</li> </ul>

	<p>There are no skill or elimination rounds in the Promotion.
